INDUSTRIAL WASTEWATER SURCHARGE RATES
(Effective October 1, 2011)

1. BOD - \$0.1999/lb. (Above 250 mg/l)
2. TSS - \$0.1950/lb. (Above 300 mg/l)
3. Minimum surcharge is \$65.00/month

Resampling performed for the purpose of determining surcharge at the request of the user shall be billed to the user in the amount of \$150.00 for the resampling, plus the cost of the laboratory analyses, which are done as a part of the resampling.

FEES (Effective August 17, 2010)

A late fee of \$1.50 plus 1 ½ % of the account balance will be added to the account at the time of the notice of delinquency.

A collection fee of \$15.00 will be added to the account at the time of the final notice.

A nonpayment service charge of \$65.00 will apply if District personnel are dispatched to discontinue sewer service.

SCHEDULE D

**MISCELLANEOUS FEES AND CHARGES
(Effective May 1, 2005)**

Septic Tank Waste

Septic tank waste delivered at Fairforest between 6:00 AM - 6:00 PM, Monday - Sunday, including holidays. \$40 per truckload, or any portion thereof, up to 2,500 gallons.

Septic tank waste delivered after hours (any time not covered above). \$75 per truckload, or any portion thereof, up to 2,500 gallons.

Septic Tank Rebate

Rebate for septic tank waste originating within District boundaries only. \$45 per septic tank rebated to customer. Only one rebate per address per year will be issued.

Grease Trap Waste

Grease trap waste delivered between 7:00 AM - 3:00 PM, Monday - Friday. \$60 per truckload, or any portion thereof, up to 2,500 gallons.

Grease trap waste delivered between 6:00 and 7:00 AM or 3:00 and 5 PM Monday - Friday or 7:00 AM - 12:00 PM Saturday and Sunday \$75 per truckload, or any portion thereof, up to 2,500 gallons

Grease trap waste delivered after hours (any time not covered above). \$125 per truckload, or any portion thereof, up to 2,500 gallons.

Truck Wash Out

Use of District truck wash out facilities. \$50 per use.
