

**Spartanburg Water System – Lake Bowen  
Application for Temporary Dock Extension Permit**

When signed by the Permittee, this Application will constitute a binding legal agreement under which the Permittee may install and maintain a temporary extension to Permittee's previously permitted dock on Lake Bowen, including a release of liability and indemnity for all claims against Spartanburg Water System (SWS) arising from Permittee's use of SWS property or use by family members or guests. Permittee shall comply with the terms of all permits and related documents for all activities conducted on SWS property.

This permit shall expire automatically upon the Lake Bowen water level returning to full pool.

## **Dock Permit**

The Permittee represents and warrants that the Permittee holds a valid Dock Permit related to the dock to be extended. Attached to this application is a signed copy of the document entitled "Primary Rights of SWS" which Permittee acknowledges to be binding and enforceable according to its terms.

## **Conformity with Plans**

The Permittee acknowledges and agrees that:

1. The dock extension will strictly conform to the plans and specifications set forth in this application and that any changes in plans and specifications will require the filing and approval of an amended permit application.
2. Once the dock extension is constructed, the Permittee will not alter it without the filing and approval of an amended permit application.
3. Permittee is solely responsible for safety, design, construction and maintenance of the dock extension and the related dock.
4. SWS's review and approval of this application and subsequent inspections of the dock and extension are for the sole purpose of ensuring compliance with SWS's private interests as owner of Lake Bowen and do not constitute a certification of any matter related to safety, design, construction or maintenance of the dock or related facilities.

## **Removal of Dock Extension Upon Lake Level Recovery**

The Permittee acknowledges and agrees that:

1. SWS may require Permittee to remove the dock extension upon 10 days written or oral notice at any time and for any reason.
2. Permittee shall immediately inform SWS and remove the dock extension if any unsafe condition should arise related to it.
3. Unless otherwise agreed to in writing by SWS, the permission to maintain the dock extension will expire automatically upon Lake Bowen reaching full pool. Unless otherwise agreed to in writing, Permittee shall have 45 days after Lake Bowen next reaches full pool to remove the dock extension from the lake and Buffer Area at Permittee's sole risk and expense. SWS may allow dock extensions to remain for a temporary, extended period of time if conditions indicate fluctuating water levels are likely in the immediate future.

4. No notice from SWS shall be required to commence the 45-day removal period.
5. If the dock extension is not removed when required, SWS may remove the dock extension from the lake and charge Permittee all associated costs and expenses including SWS internal costs, administrative costs, transportation and disposal costs, the cost of resolving claims against SWS, and the reasonable costs of collecting amounts due hereunder including attorney's fees.
