

ADVERTISEMENT FOR BIDS

Sealed bids for the sewer extension project known as the BENS CREEK GRAVITY SEWER PROJECT FROM ANDERSON GRANT SUBDIVISION TO FOWLER ROAD, will be received by the Spartanburg Sanitary Sewer District (hereinafter called the "Owner") at the Spartanburg Water Engineering Department, 175 N. Liberty Street, Spartanburg, South Carolina, until 2:00 p.m., Monday, May 11, 2021. At that time and place, bids will be opened and the amount of each bid, together with the name of each bidder, shall be announced.

A **NON-MANDATORY PRE-BID MEETING** will be held at 10 a.m. on Thursday, April 15, 2021, at the following location, which is near the project site: the Bens Creek Pump Station located at 277 Fenwick Drive, Woodruff, SC. This location is inside the Anderson Grant Subdivision. To receive directions to the project site, see contact information below.

A satisfactory Bid Bond provided by an acceptable surety (or the cash equivalent) in an amount equal to five percent (5%) of the total bid shall be submitted with each bid.

The Owner reserves the right to reject any or all bids or waive any informalities in the bidding.

Performance and payment bonds in an amount equal to one hundred percent (100%) of the contract price will be required. The bonds must be secured by cash or must be issued by a surety company licensed in the State of South Carolina with an "A" minimum rating of performance as stated in the most current publication of "Best Key Rating Guide, Property Liability."

Certificates of insurance naming the Owner as an additional insured and with limits as noted in the bid documents will be required.

Contractors submitting bids shall be properly licensed in the State of South Carolina to bid and perform the work on which the bid is submitted at the date of the bid.

Bidding Documents will be available on **Tuesday, April 6, 2021** and may be viewed and ordered online (for electronic download or hard-copy delivery) by registering with Duncan Parnell via their bid room <http://www.dpibidroom.com>. Registration with Duncan Parnell is required to obtain the bid documents and be added to the official Plan Holder's List. Only those buying full sets from Duncan Parnell via their bid room will be notified of any addenda that may be issued. The cost of bid documents and shipping is non-refundable. Neither OWNER nor ENGINEER will be responsible for copies of the bid documents obtained from sources other than from Duncan Parnell.
