## SEWER DISTRICT CONNECTION FEES

### SEWER CAPACITY FEES

Sewer Capacity Fees apply to all new service connections and may apply when there is a change in use or premises serviced by an existing sewer connection or an Industrial Wastewater Permit is modified. A Sewer Capacity Fee may apply if there is a change in water or sewer meter size.

### RESIDENTIAL & MULTI FAMILY CONNECTIONS

The expected volume of wastewater discharge for a Residential Equivalent Unit (REU) connection is 300 gallons per day, which represents the Unit Contributory Loading for a single unit residence in the SCDHEC "Standards for Wastewater Facility Construction Regulation 61-67".

1 REU = \$1,200.00
