**SPARTANBURG WATER SYSTEM
REPEAL OF BOIL WATER ADVISORY**

Effective Date: 6-26-2025

A Boil Water Advisory was issued on Monday, June 23. Spartanburg Water advises customers affected by the line repair that they no longer need to boil their water prior to drinking or cooking.

The water main has been repaired and placed back into service. Bacteriological samples were collected and analyzed by Spartanburg Water, which has a South Carolina Department of Health and Environmental Control certified laboratory. The results of the sampling indicate that the water meets state and federal standards for safe drinking water.
